



Columbia River System Operations EIS

Draft Environmental Impact Statement and Preferred Alternative

Available for review and comment February 28 – April 13, 2020

You are invited to review and provide comments on the Draft Environmental Impact Statement (EIS) and the Preferred Alternative for the operations, maintenance and configuration of the Columbia River System, comprised of 14 federal dam and reservoir projects in Idaho, Montana, Oregon and Washington. The draft EIS, developed in accordance with the National Environmental Policy Act, documents the review of potential actions and discloses the environmental effects of taking those actions.

The U.S. Army Corps of Engineers, Bureau of Reclamation and Bonneville Power Administration, as co-lead agencies, developed the draft EIS in response to the need to review and update management of the System, including evaluating impacts to resources in the context of new information and changed conditions in the Columbia River basin and in response to a court order by the U.S. District Court for the District of Oregon.

The Preferred Alternative detailed in the draft EIS is a suite of operational, maintenance and structural measures to allow the co-lead agencies to meet their congressionally authorized purposes, the Purpose and Need statement and EIS objectives, including those to benefit species listed as threatened and endangered under the Endangered Species Act. The co-lead agencies will respond to substantive comments on the draft EIS in the final EIS, to be released this summer.
