the Quileute tribe has had 2 children die in the homes of ICW employees while under their care in the last few years.(one child was was beaten to death and the other child committed suicide in the care of the tribes mental health counselor/ this child's guardian. she brain washed this child scaring him about the reunification of him to his parents to the point that he took his own life.) i have 4 signed declarations from now adult persons that were brain washed in the same manner by the same tribal employee threw medications, hypnotherapy, and regression therapy. numerous children have been taken illegally by ICW, there has been child trafficking, neglect and abuse of children, abuse of office, the tribal judge (John H. Doherty and Leona Colegrove) and it attorneys (Sarah Acker more will list upon request) openly admit to the court breaking their own laws and boasting "who is going to stop us". there has been a ongoing slander campaign, death threats psychical assault to me by the court clerk in the court house, my house was set on fire with me in it while i slept at 2 am and the list goes on. all of this is happening at the directive of chairmen/ now vice chairmen Tony Foster. i have contacted the BIA, NICWA, NICS, our various state elected officials, WA state ombudsman's office, lisa noonan WA state health dept, FBI, and numerous local authority, CPS, WA families united all to no avail. please can you help us i have had the proxy to 50 other families going threw this same corrupt system. i have gone threw 7 lawyers they too found their hands were tied. the tribe will not fallow their own tribal law, state law, federal law, or any constitutional laws. these families are being destroyed for monetary gain. this is a considerably poor tribe that has found that it can substantially benefit by the child trafficking scheme using federal and state grants threw their child protective services. i would like you to talk with myself and these many other families we could hold a meeting off the reservation anytime you would like to meet. we have had many meetings in the past at a local church here in forks WA. please review the transcripts and see my plight. i have audio transcripts, declarations, affidavits, court files and tons of witness/victim testimony.help us save our children and heal. thank you.
